## CRITERIA:

To benefit from funding of up to **£1,000** for your chosen activity, applicants are required to:

- Demonstrate the impact and outcome the funding will achieve.
- Be employees of an NFRN member – provide the NFRN Membership number of his/her employer.
- Provide a letter of recommendation from the NFRN member.
- Detail the activity they intend to pursue.
- Provide confirmation letters and pro-forma invoices from the company providing the activity.
- Submit a completed application form with supporting costs.

## FUNDING:

- Grants will not automatically be awarded.
- Applicants will be considered on the basis of merit by the NFRN Benefits Committee on a monthly basis. [The Committee's decision will be final.]
- Successful applicants will receive funding up to a maximum of **£1,000**
